Orange County Clerk-Recorder Announces Changes to Services Effective July 20

In efforts to stop the spread of COVID-19, effective Monday, July 20, 2020, the Orange County Clerk-Recorder Department closed its branch offices in Anaheim, Laguna Hills, and at the Old County Courthouse in Santa Ana to the public until further notice. The department's office at the County Service Center (CSC) in Santa Ana will remain open but will **only** offer over-the-counter services for birth, death and marriage certificates, professional registrations, and real property document recordings. For faster service, customers must submit their application online for a birth, death, or marriage certificate prior to visiting the CSC. All other services will be offered by mail only. The department's Westminster office will remain closed to the public.

Only the person requesting service will be allowed in the office.

The following restrictions are in place for real property recording services at the County Service Center to minimize exposure and to ensure the safety of staff and customers:

- Only one customer may enter the office per transaction
- Each transaction is limited to a maximum of three documents

Effective July 20, 2020, the following services must be requested via mail. No over-the-counter or walk-in service will be available until further notice:

- Fictitious Business Name Statements
- Official Records Copies
- Notary Registrations
- EIR filings

Don't Put Your Marriage On Ice - Get Married at Honda Center By the Clerk-Recorder Department

In efforts to stop the spread of COVID-19, effective Monday, August 3, 2020, Orange County Clerk-Recorder Hugh Nguyen moved his department's marriage services to Honda Center in Anaheim for a second time this year. Marriage services at Honda Center are by appointment only from 8 a.m. to 4:30 p.m., Monday through Friday. Honda Center is located at 2695 E. Katella Ave, corner of Katella and S. Douglass Road. Customers must complete their marriage license application and make an appointment online at the following link: <https://www.ocrecorder.com/services/marriage>. No walk-in service will be available at this time.

The department will be implementing strict social distancing guidelines as well as other limitations to ensure the safety of the couples and staff.

The following limitations apply for marriage services:

- Upon arrival at Honda Center, couples must wait inside their cars until a staff member contacts them by phone to approach the booth for their appointment.
- For couples looking to obtain a marriage license, only the couple can be present. **No guests allowed.**
- For couples looking to obtain a public marriage license and have a ceremony performed, only the couple and one witness may be present. **No guests allowed.**
- For couples looking to obtain a confidential marriage license and have a ceremony performed, only the couple can be present. **No guests allowed.**
- Couples will need to pay fees with a check or money order made payable to the Orange County Clerk-Recorder. **No cash or credit card payments accepted.**
- Couples must present a valid government-issued photo identification at their appointment.
- **No walk-in customers** will be taken at this time. Everyone must have an appointment.

Clerk-Recorder staff will be providing services from inside Honda Center's box office booths to ensure that a protective barrier exists between them and the couples. Again, couples must wait inside their cars until a staff member contacts them by phone to approach the booth for their appointment. This will ensure there is always a minimal amount of people at the booths.

JULY IN O.C. HISTORY

- July 4, 1900** The cornerstone of the Orange County Courthouse was placed. It included a time capsule, which was opened in 1989.
- July 5, 1870** Santa Ana's first Post Office was established.
- July 18, 1955** Disneyland opened its gates to the general public for the first time. It had opened the day before for media and special guests only.
- July 25, 1874** Southern California's first German-language newspaper, the Süd-Californische Post, began publication.
- July 27, 1769** Gaspar de Portola's expedition first saw Santiago Canyon and named it after Spain's patron saint.
