CLERK-RECORDER DEPARTMENT RESUMES PASSPORT SERVICES AT ANAHEIM AND SANTA ANA OFFICE LOCATIONS

After being forced to halt passport services due to pandemic closures, COVID-19 numbers drastically falling, and demand for travel increasing daily, Clerk-Recorder Hugh Nguyen is pleased to announce the resumption of passport services at his department, signaling a steady return to normalcy. One year after halting services due to COVID-19, the department was excited to get passport services up and running again. In what is considered a milestone achievement, on Monday, May 17, 2021, the department began offering appointments only for new passports at the Old County Courthouse in Santa Ana and at its North County branch office in Anaheim. Only new passport applications are accepted. No passport renewal services are available. Service is by appointment only. No passport services are available at the Laguna Hills office.

To complete a passport application and to book an appointment, customers must visit OCRecorder.com. Appointments are filling up fast, so book yours now! Applicants must complete their application online and make an appointment prior to visiting the offices. The Old County Courthouse is located at 211 West Santa Ana Blvd. in downtown Santa Ana and offers appointments from 8 am to 4 pm. The North County branch office is located at 222 S. Harbor Blvd., Ste. 110 in Anaheim, inside the Wells Fargo Building and is offering appointments from 9 am to 4 pm. No walk-in service will be available at either location. CLERK-RECORDER DEPARTMENT KICKS OFF PASSPORT SERVICES AT ANAHEIM AND SANTA ANA LOCATIONS

On Saturday, May 22, the Orange County Clerk-Recorder Department was proud to hold its first Passport Day event since the COVID-19 pandemic began more than a year ago. Our office served over two hundred appointments between our locations in the Old County Courthouse in Santa Ana and Wells Fargo building in downtown Anaheim. This event helped kick off the Clerk-Recorder Department's official resumption of passport services.

Passport services are available by appointment only at our North County branch office in Anaheim and the Old County Courthouse in Santa Ana. Applicants are required to bring all necessary documentation to their appointments. To book an appointment and view all requirements, please visit OCRecorder.com.

Passport services are by appointment only. Please bring the required documents below, along with a completed and unsigned <u>DS11</u> form and the correct fees (on the next page) to your appointment. To schedule an appointment, please visit <u>OCRecorder.com</u>.

PASSPORT CHECKLIST
Proof of U.S. Citizenship (certified copy of birth, citizenship or naturalization certificate, expired passport, etc.)
Proof of Identity (Driver's License, Identification Card, Military ID, Naturalization Certificate, etc.) Note: Minors under 16 years of age must submit copies of both parent's IDs
Recent Passport Photographs in Color (taken within the last six months and 2"x 2" in size)
Passport Fees (Please see reverse side for fees and payment requirements.)
Social Security Number (The application requires the social security number only. We do not require to see the actual social security card but please know your social security number to complete the application.)
Expired Passport and a Certified Copy of the Applicant's Birth Certificate (For minors under 16 years of age to obtain a new passport)
All applicants must be present.
Please ensure you follow additional instructions listed on your passport application.
Fee information listed on other side of this checklist.
Appointments are highly recommended.

Interested in getting a passport?

Passport services require two separate fees. The Passport Application Fee must be paid by check or money order to the U.S. Department of State. The processing fee is paid to the Clerk-Recorder department by any method: cash, check, money order, or card. Passport services are by appointment only. To schedule an appointment, please visit OCRecorder.com.

Passport Fees

Passport Application Fees and Processing Fees are paid separately.

Passport application fees are paid to the U.S. Department of State with a check or money order only. Processing and passport photo fees must be paid to the Clerk-Recorder Department with any form of payment—check, cash or credit/debit card.





May 4, 1919
