#### Clerk-Recorder Launches Interactive Chatbot for Instant Customer Support

How do I obtain my birth certificate? What do I bring for my marriage appointment? These are just a few examples of questions that can be answered on your screen right away! Orange County Clerk-Recorder Hugh Nguyen launched a chatbot named CRBot to the Clerk-Recorder website allowing customers to get their questions answered instantly during any hour of the day and seven days a week. On March 21, 2024, customers were able to use this chatbot to input questions about the department's services and receive immediate answers. The launch of CRBot is expected to reduce the number of calls to the department's information line and result in shorter wait times for customers needing to speak with staff on more complex questions.

#### "CRBot will be a convenient tool for customers who need information about our services and want quick responses without waiting on the phone," said Clerk-Recorder Hugh Nguyen. "I understand our customers have busy schedules, and I am committed to implementing innovative technologies to make accessing information on our services efficient as possible."

To experience CRBot, visit OCRecorder.com and tap on the chat bubble icon on the lower right of the screen. A chat window will appear allowing the user to type in their intended question and receive an instant response. CRBot is also mobile device compatible for users accessing our website from their smartphones.

Key features:

- CRBot is knowledgeable of customers' most asked questions regarding department services and is accessible 24/7.
- More complex questions may be directed to a live chat agent who will be available during normal business hours.

For any questions, please call the department's information line at (714) 834-2500 during normal business hours Monday through Friday from 8 a.m. to 4:30 p.m., except holidays.



## MARCH IN O.C. HISTORY



Historic church and school are prepped for their move from the heart of old El Toro to Heritage Hill Historic Park in Lake Forest, 1978

March 5, 1991	Lake Forest voted to incorporate as a city. The measure passed 5,590 to 2,614. Up to this point, the unincorporated community had been known as El Toro since the 1880s.
March 5, 1878	Pioneer, Huntington Beach Mayor, and longtime Orange County Supervisor Thomas B. "Tom" Talbert was born.
March 12, 1876	Fredrich Conrad opened Tivoli Garden in Anaheim – the first amusement park in the Orange County area. It included a bowling alley, shooting gallery, dance pavilion, croquet, and beer gardens.
March 21, 2006	"The Real Housewives of the OC" – a "reality show" set in Coto de Caza, debuted on the Bravo cable network.
March 27, 1955	Rev. Robert Schuller – later known for the Crystal Cathedral and his "Hour of Power" television show – preached his first sermon in Orange County from the roof of a snack bar at Orange Drive-In Theater to a congregation sitting in their cars.
